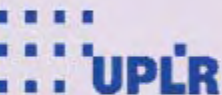


Structura încasării impozitelor în anul 2008 în Republica Ceha

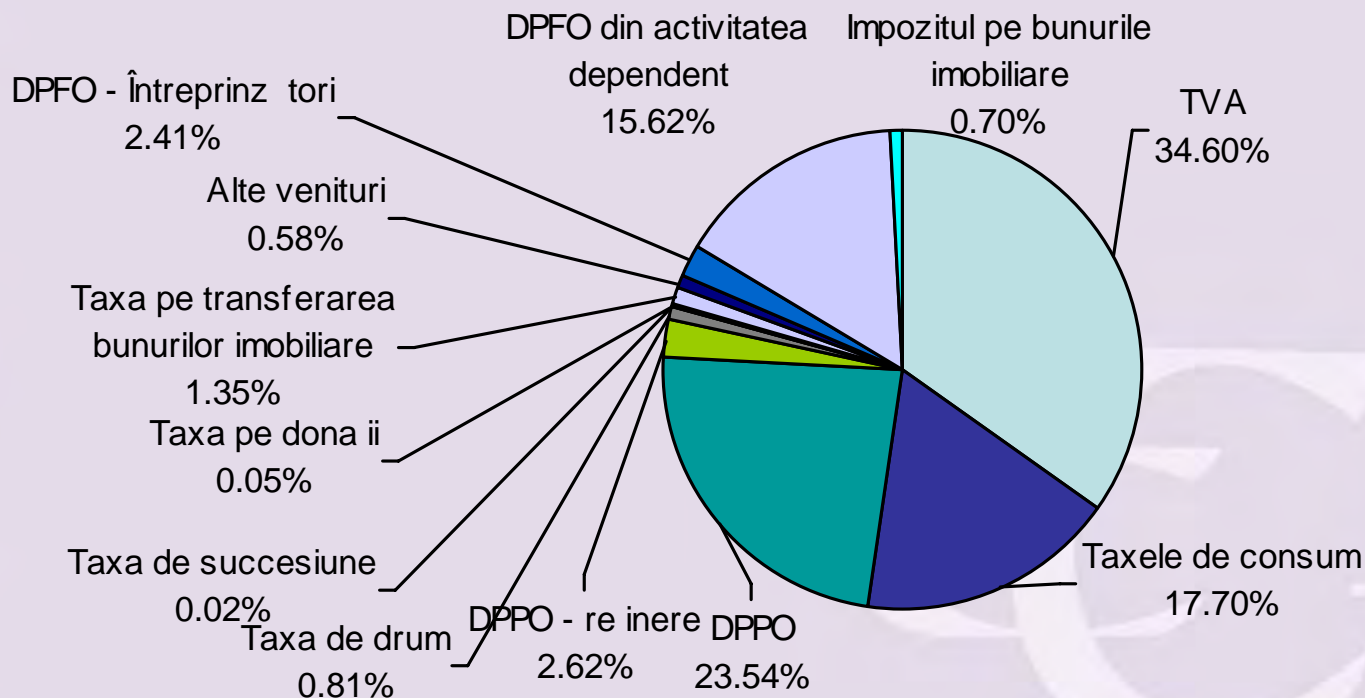
